

## **Early DAR Members** Part of Suffrage Movement 1913-2013

On March 3, 2013 members of the Daughters of the American Revolution joined in a parade with 5,000 women from 13 other national institutions and organizations to commemorate the Suffrage Centennial. This is the 100<sup>th</sup> anniversary of the 1913 Woman Suffrage **Act**, also known as the 19<sup>th</sup> Amendment to the U.S. Constitution. The National Archives will display the 19th Amendment which will be the last time to see this document until 2020.

The Daughters of the American Revolution has a number of ties to the women's suffrage movement of the 1890s to the early 1920s. Many well-known suffragists were also DAR members, including Susan B. Anthony, Alice Paul, Mary Garrett Hay, Julia Ward Howe, Belva Lockwood, Harriet Taylor Upton, Sue Shelton White, and Frances Willard.

A new exhibition in the Daughters of the American Revolution Museum in Washington, D.C. shows the inherent connection of the subject matter to the DAR. The exhibition entitled "Fashioning the New Woman" examines women in the era of the founding of DAR: 1890. Images of the costumes from the era can be viewed at www.dar.org/fashioningthenewwoman.

The first members of the DAR were part of a larger trend in the United States: that is, women were creating clubs of many kinds, from literary and other cultural clubs, to historical and genealogical societies, to organizations with goals or social activism. Suffrage banners and other artifacts, including letters written by Susan B. Anthony pertaining to the suffrage movement are also a part of the exhibition. The exhibition can be seen online:

# **Trooper Gary Scott Retires**

Gary D. Scott, age 62, has retired from the Indiana State Police force after 34 years of distinguished service. His first entry into law enforcement was as a Security Police Officer in the United States Air Force from 1969 to 1973. Gary Scott served as a police officer in Newman for a short time from 1975 through 1977 following his service with the Air Force. After attending the Indiana State Police academy, Gary was assigned to Lowell District (#13) on road patrol on January 2, 1979, beginning his career of continued service of upholding the law.

Among the a n accomplishments during his tenure with the Indiana State Police, Mr. Scott participated in Operation Bar-Tab from 1982-1987 investigating judges in Lake County courts who were accused of fixing DUI tickets. The FBI-led inquiry resulted in a total of 19 individuals being charged, including two judges, a

deputy prosecutor, and several other persons associated with court proceedings. Officer Scott was awarded the Distinguished Hoosier Award in January of 1989 for his work in the case.

He went on to provide assistance to the U.S. EPA's investigation of the Hammond Sanitary District who illegally dumped 14 billion gallons of untreated waste water into the Calumet River. His work with the EPA lasted from 1990 to

From 1996 to 1998, Officer Scott's temporary duty assignment (TDY) was as a member of the Gary Response Investigative Team (G.R.I.T.) where he again worked with the Federal Bureau of Investigation and assisted the City of Gary with their out of control homicides and other violent crimes. In 1996 Gary was the "Murder Capital of the United States." The G.R.I.T. Task force was established by Attorney General Janet Reno.

Between the years of 2003 to 2007, Gary Scott's TDY was a detail with the U.S. Secret Service investigating bank and wire fraud. Suspects in the case ranged from Chicago street gangs to international criminal groups. Chinese, Nigerian,

Russian, and Columbian individuals were involved in wrongdoing. A total of 89 suspects were charged during the resolution of the investigation. U.S. Secret Service Director Mark Sullivan awarded Mr. Scott a commendation in 2008 for the part he played in the investigation.

During his final duty assignment, Gary assisted the FBI again with their Public Corruption Task Force, investigating public corruption cases where public officals of local cities and counties were involved in multimillion dollar mortgage fraud schemes. Eleven individuals were

indicted following the police work that lasted from 2008 to 2013. After the completion of the assignment, FBI Director Robert S. Mueller III awarded Officer Scott a commendation for the part he played in bringing the corrupt officials to justice.

Perhaps the most dramatic moment of his successful career came during a shooting/ stabbing incident in Hebron, Indiana. The suspect fired on the

responding officers before attempting escape. During the flight he used his two children (ages 8 and 5) as human shields. The suspect was tackled and disarmed of a 38 caliber pistol and a 12 gauge shotgun. Gary was awarded the Silver Star for heroism during the confrontation.

What does such successful and highly decorated officer do now, one might ask? He relaxes, of course! Gary resides with his wife, Joyce L. Thode, whom he married in July of 1969 in their home in Cedar Lake, Indiana; 15 miles south of Hammond. Gary is also the proud father of two children: his daughter, Holly (Scott) Fisher, who also lives in Cedar Lake with her two kids; and a son named Jay who is a Master Sergeant in the United States Air Force, currently stationed in Fairbanks, Alaska. Jay has served as a fireman for 17 years in the Air Force.

Gary's parents are Marjorie and Wally Hahn of Newman, IL and Dale and Theda Scott of Arthur, IL.

#### Family Traditions Merge with National School Breakfast Week

Growing up my dad always cooked us breakfast. Yes, I said COOKED, and I said, DAD. First let's talk about COOKING a breakfast. Due to the morning hustle and push to get parents and kids to work and school on time, it becomes harder and harder to provide a healthy breakfast in a short time frame for the family. It is easier to pop something in the toaster or pour milk over sugary cereals.

Cereals were created to help with digestion in patients staying at "Sanitariums" or "Health Spas" in the late 1800's. They were first introduced as Granola and Corn Flakes; becoming very successful in place of pork for the morning breakfast. Later in 1953, Sugar Smacks were introduced containing 56% sugar and starting the cereal explosion by adding sugars and placing prizes in the box for children everywhere. Eggs and bacon faded as the morning staple.

During the time of the cereal explosion occurred, other events were transpiring as well. Many experts believe the first upswing of obesity (BMI values) started after WWI, with a decline during the Great Depression, and then an accelerated upswing after WWII. Komlos and Brabec (2010) propose the following as irresistible, impersonal, and technological forces that attribute to the changes;

- the major labor-saving technological changes of the 20th century,
- the industrial processing of food and with it the spread of fast-food eateries (To illustrate the spread of fast food culture, consider that White Castle, the first drive-in restaurant, was founded in 1921. McDonald started operation in the late 1940s, Kentucky Fried Chicken in 1952, Burger King in 1954, Pizza Hut in 1958, Taco Bell in 1962, and Subway in 1962.),

# Norovirus Outbreaks – Stay Healthy, Wash Your Hands

#### "Stomach bug" circulating

SPRINGFIELD – No doubt you probably know of someone who has been sick with a "stomach bug" this year, typically caused by norovirus. Norovirus causes vomiting and diarrhea and is very contagious. According to the Centers for Disease Control and Prevention (CDC), more than 80 percent of norovirus outbreaks occur from November to April. The CDC estimates that more than 20 million people, or about one in every 15 Americans, are infected with norovirus.

"Norovirus is the most common cause of stomach illness in the country," said Illinois Department of Public Health Director Dr. LaMar Hasbrouck. "However, the easiest way to avoid becoming ill is to wash your hands. Viruses can contaminate surfaces and objects touched by someone who is ill. If your hand then comes in contact with your mouth, chances are you will end up becoming

Norovirus can spread quickly from person to person in crowded places like schools, long-term care facilities and daycare centers. A person who is ill and prepares or serves catered meals or food in a restaurant can contaminate food, causing others to become ill.

Symptoms of norovirus infection usually include diarrhea, vomiting, nausea and stomach cramping. Other,

less common symptoms may include lowgrade fever, chills, headache, muscle aches and general sense of fatigue. Norovirus illness is usually not serious and most people are better in a day or two. But, norovirus illness can be serious in young children, the elderly and people with other health conditions. According to the CDC, norovirus causes more than 70,000 hospitalizations and 800 deaths in the U.S. each year.

Tips for avoiding norovirus:

- Frequently wash your hands, especially after toileting and before eating
- Thoroughly clean and disinfect contaminated surfaces immediately using a bleach-based cleaner. Or use one part bleach to nine parts water (1:10 dilution).
- Increase the frequency of cleaning high touch surfaces such as

- the associated culture of consumption,
- the rise of an automobilebased way of life,
- the introduction of radio and television broadcasting,
- the increasing participation of women in the work force, and




