Over 100 people attended the Soup Supper sponsored by the Freedom Festival Committee. Their efforts of providing a great meal for the community brought in needed donations toward the cost of the fireworks display observed by hundreds of people during the annual summer Freedom Festival celebration in mid-June. Fundraiser chairman, Jim Biddle, indicated that the funding is approximately 2/3 complete after the soup supper and thanked the community turn-out for supporting the continued program. 
The student learners will go through a 3 hour program on basic first aid including treating of wounds and securing medical support as needed. In the afternoon 3 hour

## Library Joins Largest Consortium to Offer More

On April 9, Newman Regional Library District will become one of 427 libraries in central and southern Illinois to share their automated catalog. This will bring a few minor changes to our library users.

These changes include several benefits: You will be able to borrow more materials from further-flung libraries more quickly than before. You can borrow and return items at more libraries. There will be a new online catalog which you will still be able to access from NRLD's website at www.newmanregionallibrary.org.

The merging of the systems will require us to stop taking requests for interlibrary loans on March 15 until April 10. Please save your information and we can help you request the items once we have transitioned to the new system. You can still visit other libraries and checkout items with your card until the first week of April. During that week we will be using a temporary program so data can be transferred from one system to the other. This will mean that we will not be able to issue new cards during that period or check out items to people from other libraries.

"We hope that these minor inconveniences won't cause problems for our patrons. Peggy Hillard and I will work hard to make this transition as seamless for everyone as we can," assured librarian, Renee Henry. In addition to providing an improved and more modern catalog, this is all being done at no

additional cost to the taxpayers or the library. There will be no change in our participation and your borrowing e-books and audiobooks through MyMediaMall.

In 2011, four Illinois library systems, including Lewis & Clark Library System, Lincoln Trails Library System, Rolling Prairie Library System, and Shawnee Library System, merged to form the Illinois Heartland Library System (IHLS) in response to cost savings required by the financial stress in state government. So far, the merger has only affected behindthe-scenes operations at the member libraries and not our patrons' library experience. However, beginning in April, our patrons will see a few changes in how they use the library.

All of your library's item and patron records were stored in the same type of shared database. These shared databases were used to record circulation of items, to facilitate interlibrary loan and allowed NRLD's patrons to use their cards at other libraries. On July 1, 2012, the four systems merged to form SHARE (Sharing Heartland's Available Resources Equally).

On April 9, 2013, SHARE will go live with a new automation platform. Each of the former cooperatives will change from having over 2,000,000 items in each of their online catalogs to 9.5 million, and from more than 250,000 patrons each to nearly 1,600,000 total. Several library experts agree that SHARE is the largest library automation consortium in the country.

## Pet Talk with **Dr. Sally Foote** DVM



About a month ago, our beloved yellow lab mix Butterscotch had a stroke. He started off with some increased stumbling and balance problems on a Saturday night that progressed the next day to a full blown head tilt and falling to the side. Despite treatment, he became worse over the next day and my husband, daughter and I made the decision to end his difficulties by bringing him to a friend DVM for euthanasia. It was difficult for us, and Butterscotch was able to go peacefully with Tom and myself at his side. We miss him, and Bella is adjusting without the big guy. You read an awful lot about the crazy Bella dog, but now I will

tell you about Butterscotch. . We adopted Butter from the local shelter about 7 1/2 years ago at an estimated age of 8. He was picked up as a stray with a leg so crippled with arthritis he could not walk on it. He was gentle, friendly, and looked like the first dog Tom and I owned. When I saw him, I knew we had to keep him. Our dog at the time, Sissel, was getting a bit older and we needed to have the backup dog to avoid the empty house syndrome after the older pet dies. Sissel was not always receptive to other dogs so, I thought let's have them meet and see how it goes before making a

commitment. Do pets know what we need and want? Sissel just came up to him, sniffed him over, and laid down and ignored him. There was not tension, no staring, guarding or anything. Butter was his usual laid back self so home he came. The two of them always got along - no fighting over toys, food, space or anything. Butter thrived on medication to reduce the pain in his knee, joint diet and daily walks. He was such a loveable dog around people and kids he was almost perfect.

One day while walking him, he saw a dog across the street - he immediately wanted to rush up to that dog in a very forward and not exactly friendly way. The dog was a little toy breed and the manner that Butter hunkered down with his head level, silently stalking I knew right away - we have some predatory aggression here. A few days later in the back yard he quickly lunged after a squirrel using the same manner. I learned very quickly that not all dog aggression presents the same. Some aggression is very specific to the situation - such as predatory aggression - and must be controlled. From this incident I knew Butter would not be able to play at a dog park. He would very likely aggress on a small dog and there was no way I would take that chance. Butter did not get into a fights, but there were a few close calls when little dogs off leash would come trotting up to him and we had to get him away. It was very surprising to people who knew how friendly and sweet he was. I guess that is my point - Butter showed how there are different types of

#### Health Notes Douglas County Health Department American Red Cross

I like History. Not the history of memorization but the history of stories stories of remarkable people and remarkable events. After all, our history is what has propelled us to where we are today. History is what we can embrace or blame. It is our roadmap and hopefully our lessons in learning. In history we can often find the worst and the best of

Clara Barton was a remarkable woman. She was born Christmas Day 1821 in North Oxford, Massachusetts. When she died in April of 1912 at the age of 90, she had created a broad resume of programs that promoted human welfare and social reform.

Clara started her professional life as a teacher, eventually opening up a free school in New Jersey. In 1955 she moved to Washington DC and began work as a clerk in the US Patent Office and was likely the first woman to ever hold a government job. In 1864 she was appointed by Union General Benjamin Butler to be the "lady in charge" of the hospitals at the front of the Army of the James. There she became known as the "Angel of the Battlefield" for the nursing care she provided.

After the Civil War she ran the Office of Missing Soldiers in Washington DC. She became active in the women's suffrage movement and black civil rights. And then in 1881, at the age of 59, she still had enough energy to establish the American Red Cross.

It is particularly timely to consider this portion of history with the number of disasters that affected the United States

in 2012. Tornadoes, floods, hurricanes, snowstorms, fires, etc. The list is rather large. However, one constant has remained in place for many years. As disasters occur, the American Red Cross

Shelter, food, emotional support and other necessities are provided in American Red Cross disaster responses worldwide. The ARC provides 24 hour support to members of the military, veterans and their families in war zones, military hospitals and on military installations. They collect and distribute blood products. And they provide training each year in first aid, water safety and other skills.

The Red Cross is not a government agency. It runs on donations of time, money and blood to provide services. Each year it responds to nearly 70,000 disasters, provides training to more than 9 million people and collects and distributes more than 40% of the U.S. blood supply. And this could not be done without the generous support of individuals like you - people that donate their money, time and blood to further Clara Barton's humanitarian mission.

During the 1900 Galveston Hurricane, Clara Barton, President of the American Red Cross, did her final stint of field work, providing relief for victims. In 1904 at the age of 83 she resigned her position and duties. Instead of kicking back and relaxing she then founded the National First Aid Society.

History shows that Clarrisa Harlowe "Clara" Barton was one of the good ones. She lived a life of selfless giving from nearly beginning to end. And we are the beneficiaries. Pay it forward. March is American Red Cross Month. Consider donating your time, self or money to Clara's mission.

aggression and it takes a specific situation for it to show up. One aggression screen do screen does not screen for all types of aggression.

Butter had thunderstorm phobia. I never had a dog with this problem, but I was aware of other client's dogs that were affected. I had been reading on new treatments using pheromone products and other medications but I was not really clear on what worked best. The first time we had a storm with him home, the kitchen table started shaking. I was wondering what was



going on when I saw that Butter was trembling and laying against the legs of the table thus causing the shaking. I could not coax him to settle and I could see him drooling and panting and pacing. I had just gotten the DAP/ Adaptil collars in so I ran back to the office and put one on him. He settled down after 10 minutes which made us all feel better. Over time I learned more and developed a plan that had Butter sleeping through many a storm. From my experience with him I wrote out Butterscotch's play list of songs that

soothe dogs through storms and my blog entry Thunderstorm nightmares no more showing how to set up an area for a dog to calm during a storm. So, Butter is still helping other fearful pets learn to settle and calm with fears.

Butter was a wonderful guest on television. He appeared on CI living Champaign a couple of times and was on the Paw Report with WEIU twice. He was such a hit at the stations. When I would walk through he greeted everyone at every desk and they loved to pet him. I don't think he ever upstaged any host and he was very polite about any bathroom needs taking care of that before we entered any building. He is also featured on some of my instructional videos on my clinic website www.okawvetclinic.com again, teaching clients, veterinarians, and technicians about rewarding during the veterinary visit to make it less stressful on the pets and everyone. So, again he is still teaching others about behavior and good pet care.

Every pet has a special place in one's heart. Butter certainly has that in my family. I do miss him. #### Revival of Hope: The 2012-2013 Raider Basketball Men of the Blue and Gold

To our two graduating seniors, I was honored to watch you grow and play throughout your four years. Cole Bogle and Bobby Lance, I am very proud of you! Cole grew from playing in the junior varsity ranks to becoming a go-to player in his final two years. I feel his coming of age was during his junior year when he scored 30 points in a home game against Lovington. It showed that he was ready to rise to become a major factor and even though his numbers were down this season, he still brought the key numbers and plays down the stretch. I felt bad for Bobby after he injured his knee late in the season, but his role play coming off the bench was also huge this season. Bobby did most of the "grunt work" that really doesn't show up in the box score. That work is one of the building blocks in providing the mold in producing scoring opportunities and keeping the team in the game to win. Thank you both for the four years of hard work. You helped in starting the resurrection of the program and it will never be forgotten.

I have to tell you, I am very excited and confident about our returning players for next season. Our sophomore trio of Andrew Donithan, Cyrus Furgeson, and Eli Furgeson raised their games and has the chance to become something special. Andrew scored in double figures for pretty much the entire season and grew in confidence to battle inside with players much bigger than him. Cyrus started off the season red hot, but then struggled a bit during the middle of the year, then adjusted to come back strong with his shooting from the outside. Eli had to come in when injuries hit the squad and he went on a tear when he ended up the leading scorer in several games coming off the bench. With these guys coming back, there is no telling what they can do for an encore. Our junior class also stepped up this season. DJ Castillo was huge defensively all season long and it showed in the final four games of the season. He

showed that he was not going to go down quietly and that he had arrived to show he was a force to be reckoned with. Nathan Haynes also grew as a player embracing his role as a sixth-man off the bench providing key steals and assists before injuring his hand and wrist to end his season. Kaleb Hood also provided huge rebounds and scoring down the stretch which gives the Raiders a formidable one-two punch on the inside. 


to honor her Junior High Volleyball players and special awards winners.

## Leaders Move to End Voting at Schools,

#### **Protect Students**

SPRINGFIELD -Comptroller Judy Baar Topinka, State Rep. Jack Franks and State Sen. Tim Bivins joined the Illinois Association of Chiefs of Police and other law enforcement leaders in announcing legislation that would remove polling places from public and private schools, and ultimately protect students.

Planned legislation amends the state Election Code and state School Code by eliminating public and private schools as voting site options and striking language that requires School Districts to make buildings available as polling places.

"This is a common-sense step that puts students first," Topinka said. "There is no reason to have members of the public strolling through school parking lots and entering buildings where classes are being held. There are government buildings, churches and other polling place locations that do not put students at risk or disrupt the school day, let's utilize them instead."

Safety concerns have prompted communities in Illinois, and across the country, to rethink school polling locations. In addition, lawmakers in Indiana, New York and Virginia are considering statewide bans on voting at schools. Legislation introduced in New Jersey would require schools that serve as polling places to have a written security plan.

"As schools across the country reassess security measures, it makes sense for the state to eliminate this potential threat to students," Franks said. "We're talking about hundreds, even thousands, of people walking on school grounds, going into school buildings and potentially coming into contact with our students. It is an unnecessary risk that we should no longer take."

On Tuesday, law enforcement leaders stood with Topinka, Franks and Bivins in announcing the proposed change. Representatives from the Police Benevolent and Protective Association, the Illinois Chiefs of Police Association and several Police and Sheriff's Departments were unified in their support of the new legislation.

"As the Chief Law Enforcement
Officer for the Village of Riverside it's
my duty and obligation to prepare for
the worst - and to prevent it, if
possible," Village of Riverside Police
Chief Tom Weitzel said. "School
administrators are already hiring
officers to work security details at
schools throughout Illinois during the
next election. We can do even better by
removing the polling places sites
completely."

## Workshop to Focus on Small Acreage Opportunities

Dave Shiley, Extension Educator – Local Food Systems and Small Farms

If you have been searching for a way to put a few extra acres to work to bring in additional income or to develop a hobby, then you may want to attend the "Putting Small Acres to Work" workshop on March 16<sup>th</sup> in Mattoon. The workshop will be held at the Sarah Bush Lincoln Health Center's Education Center from 8:30am until 1:30 pm.

Educational sessions begin at 8:30 with three concurrent programs to choose from each hour through 11:50. A general session will be presented on Energy Alternatives for Small Acreage as lunch is served at noon. The University of Illinois Extension is sponsoring the workshop to help people who have a few acres learn ways they that they can put them to use.

Perhaps you have livestock, or are considering buying some. If so, you can learn how to select the correct fence for the job. Brad Halbrook from Modern Livestock Systems will offer fencing designs that will help keep your livestock in their pasture or paddock. Dennis Bowman from the University of Illinois Extension will also be presenting a session on how to maintain a healthy pasture. His discussion will include how to determine how much pasture land is needed to keep your livestock healthy.

If you are wondering how to produce your own honey, Larry Quicksall from the Crossroads Beekeepers group will be discussing how to get started in this enterprise. His presentation will include resources and how to get connected with local beekeepers for continued mentoring.

Do you have wooded acreage on your property? Dave Shiley from the University of Illinois Extension will be presenting information about increasing your profits from your forest. You will learn about forest planning to manage your resource for timber and non-timber products, such as shitake mushrooms and ginseng.

In addition, Brian Lau and Kevin Augustus from Land A Family Farms will share their experiences and expertise regarding their farm operation. Brian will talk about the poultry and egg production part of their operation. His presentation will include an explanation of regulations regarding the operation. Kevin will be talking about the vegetable production side of the farm. His presentation will include an explanation about their use of a CSA or Community Supported Agriculture marketing technique used to sell their produce.

Finally, staff from the Coles County Farm Service Agency office will be on-hand to answer your questions regarding the USDA's Micro Loan program for beginning, niche and the smallest of family farm operations.

The cost of the workshop is \$30 per person or \$40 per couple, which includes lunch and materials. Students may attend for \$10. Advanced registration is required for the workshop with the registration deadline being March 13<sup>th</sup>. The city crew employed the vacuum truck to make it easier to work around the complicated tangle of phone and power lines also located in the area rather than dig in with the city's backhoe.

#### **Newman City Council Holds March Meeting**

The Newman City Council opened their monthly meeting at 6:32pm with Mayor Jim Allen presiding and all council members present. Also in attendance were city employees Mark Fraser, Dennis Kibler, Police Chief Shane St. Clair, city treasurer, Mike Hutchinson and newspaper editor, Dana Hales.

Minutes of the previous meeting were approved by 6-0 vote. The treasurer's report was reviewed and also approved with a 6-0 vote. The current bills were reviewed with a question on a billing from O'Herron's on a police concern, so that billing was held until further determination could be made. The rest of the bills were approved to be paid including an addition of \$50 for design work done on renewal stickers for golf carts within the city.

Old business included discussion on the old Dime Store building located at the corner of Broadway and Yates streets concerning ownership and tax payments to move toward disposition of the building. Water tower contract negotiations for repainting and refurbishing the interior were discussed with some information coming from at least four different companies. One company representative entered about 7:20pm to answer any questions possibly posed by the council. They were still looking at all avenues of possible painting and maintenance concerns without any

decisions being made. Other companies were yet to provide any concrete information toward solutions of water tank concerns. Continuations of the bids will follow in the April meeting.

The ordinance book was discussed with updates that had been made. The first to be discussed was a modification to the liquor ordinance in respect to residency. It had been modified to include ownership of establishments must live within the township of Newman.

A second ordinance concerned the appropriate driving age of neighborhood vehicles (golf carts) within the city limits. Drivers must be at least 18 years of age and possess a valid Illinois driver license.

New business entailed the potential sale of city property located on the highway. The business property formerly known as D & S Oil Station will go to a public auction in April to a successful bidder of at least 80% of the appraised value of the property. The sale date was set for April 13th.

Dennis gave a report on the work done Monday on some water line concerns and also the state of the alleys in the city. He is planning on using a heavy roller to go down the alleys to flatten them out from the continued usage by the garbage haulers.

Shane St. Clair gave a monthly police report identifying the following activity

for the month: 156.25 hours of patrol and office work; 510 miles patrolled; 11 traffic stops; 2 theft reports investigated; 1 battery report investigated; 1 domestic concern investigated; 10 verbal warnings issued; 1 assist to the County; 1 ordinance violation; 1 motor assist; 1 death notice; 1 officer to Court; 5 citations issued; and 1 arrest to jail. With no questions for Chief St. Clair, he remained as an observer until the meeting ended.

Rod Bisby, member of the city zoning board, was there to inform to the council about a request from a resident for a zoning variance for a proposed building on the corner of High and Coffin Streets. Jake Bosch had proposed building a structure to house a mobile home and other equipment. He had approached the adjacent property owners and had secured clearance from them and wanted to move forward with the process to enable him to construct a storage facility at the site. The council will wait until the zoning board meets again and has their determination on the completeness and accurateness to the guidelines for the construction.

The finance committee had met since the last meeting, but gave not report.

With no further items for discussion the meeting was closed at 7:40pm.
