



Library Summer Reading Program All Set to Travel

The theme for the summer reading program is Have Book, Will Travel. And children from age 3 to sixth grade can rack up the miles reading from May 28 through August 3 at Newman Regional Library

Students check out books from the library; read them on their own time; log the books they read; get paid Book Bucks for reading; and spend their bucks in the Travel Market. It is a relatively easy process that encourages children to keep reading over the summer. Librarian, Renee Henry, notes "This program is gives the reluctant reader some incentive to read; and rewards the book lover for what they would be doing anyways!"

A special feature of this year's program is the opportunity for students to complete a Reading Passport. Those who read one book on each of the following will receive a special reward: the world, outer space, history, science fiction, fantasy, adventure, mystery, poetry, biography, and how-to. The reward will be a trip to see an educational travel film at the new Savoy IMAX Theater.

The program is free, but registration is required. A library card is required to participate. All Newman and southern Murdock Township residents support the library through their property taxes, so they just need to bring identification and something with their address on it to get a library card. Cards are issued to anyone age 8 or older. Those families who live elsewhere in Shiloh School District may purchase a library card. The fee is \$.0025 times the taxable value of your property, or if you rent, it is 5% of your monthly rent. The Reader's Bridge program will cover 90% of the fee if you are a low income family. You Should Be Receiving Your Douglas

County Real Estate Tax Bills provided by Bobbi Murray

Douglas County Real Estate Tax bills were mailed on Friday, May 24, 2013. The first installment due date is Friday, July 5, 2013 and the second installment due date is Thursday, September 5, 2013. This year we are again using a mailing service. You will receive a separate envelope for each tax bill. Taxpayers with a high volume of tax bills will receive a single large envelope. Please look over your tax bill(s) and make sure all of the information is correct. Please read the back of your tax bill. It is the responsibility of the property owner to report all address changes to the Assessor's office at 253-3031. Questions about assessments and exemptions are to be directed to the Assessor's office. If you do not receive a tax bill and should, please call the Treasurer's office at 253-4011. Failure to receive a tax bill does not relieve a taxpayer from their tax liability. You may pay your taxes at any participating bank in Douglas County. Contact your local bank for hours and information. We accept postmark as date of payment, so please feel free to mail your payments to: Douglas County Collector, PO Box 320, Tuscola, IL 61953. If you wait and mail your payment on the due date, we suggest that you request your post office hand cancel your stamp. Also, check with your post office for any time cut-offs that may affect the postmark date on your envelope. If you are mailing your payment and would like a receipt other

You may also bring your tax payment to the office of the Collector/ Treasurer at the Douglas County Courthouse, room 206. You may also drop your payment in the gray Circuit Clerk's drop box at the east door of the Courthouse. Payments in the drop box will be picked up at 8:00 AM each business day. You may also pay your taxes through Illinois E-pay over the phone or internet with most major credit cards. For instructions for phone and internet payment, go to our website at www.douglascountyil.com and click on Treasurer on the left hand side of the page or call this office if you do not have internet access. Convenience fees apply. See the website or call this office for fee amounts. There will be no grace period after the due date. Tax payments received (other than with a postmark of July 5, 2013 or before for the first installment and September 5, 2013 or before for the second installment) after each installment due date will be charged a penalty of 1.5% per month or any part of a month that the installment remains delinquent. If your taxes are paid by a mortgage/escrow company, you must forward a copy of your bill to them for timely payment. Please read the back of your tax bill, it contains this and other very important information.

So what is a good disaster plan? One that is simple, easy to do and everyone in the home know what to do. We live in the tornado belt - so what is the best place in your home for tornados? Be sure there is space for you and your pets. Then practice in a fun way calling your dog or cat to the bath room. Toss treats in there and praise them. Call them in there when you brush your teeth. If it is the basement, toss a toy down the stairs so they go down and come up and make a game of it. This way when you need to move fast they will too.

Keep the collar or harness on your dog or cat. Put your cell phone number on an id tag. Train your dog or cat to go into a carrier easily. Keep the carrier out and toss food kibble in there for them to go in as you point. Make it fun - like a game. A carrier can be very protective in a storm. If your dog hates the carrier see my video http:// www.youtube.com/ stop crate fears in dogs drsallyjfoote you tube channel which shows how to train an adult dog to like the crate.

I know this takes time, but what if you are like that woman in the video looking for your pet. If that little dog was loose in the house, it is very likely he would have been blown away (literally in a 200 mile per hour wind) and have died. What would be the difference in this woman's life? I think she would have been heartbroken for a long time. Her plan made her life better, Bowsie's life better and saved those first responders from trying to locate the dog and finding shelter that is not there for the dog.

- 3 tbsp honey





END OF AN ERA: Panthers Close Chapter Bowing Out in Bogic and Chance Economic Close Chapter Bowing Out in RBIs in the second Sectional Semis

It is a time that we as baseball fans didn't want to see arriving just yet. It is a time that we hoped would continue just a little bit longer so that the magic and moments would be cherished for a lifetime. Unfortunately, the date of Wednesday, May 20, 2013 would be a date that now becomes a part of history for both the Shiloh and Heritage School Districts. It was the day the East Central Panthers played their final baseball game as a group. The Panthers came off of a regional championship two weeks ago on home soil and looked to reach their second sectional championship game in four years and make this final year of the co-op program a memorable one in the process. The team under Head Coach Mike Taylor traveled to Leroy last Wednesday night for the round of 32 against the Salt Fork Storm to see who would make the Sweet Sixteen and have the opportunity to advance to the Elite Eight and be one step closer to this weekend's Class 1A State Finals in Peoria.

The game started off strong for East Central as the offense was getting to Storm starting pitcher Cole Taylor as Cole Bogle and Chance Lemmon

and third innings as part of three runs in the first three innings and Panthers starting pitcher Cyrus Furgeson continued where he left off from the regional championship game retiring the first nine Storm hitters to take an early 3-0 advantage. 





SPRINGFIELD, IL— United States Department of Agriculture's (USDA) Illinois Farm Service Agency (FSA) State Executive Director (SED) Scherrie V. Giamanco encourages farmers and ranchers to enroll for the 2013 Direct and Counter-Cyclical Payment Program (DCP) or the Average Crop Revenue Election Program (ACRE) before the deadline. Producers who wait until the last minute to sign up could face increased waiting time in FSA county offices.


"We understand that producers have become very busy, but they can't forget to visit their county office and sign up for DCP or ACRE," said Giamanco. "Just as farmers and ranchers plan their spring plantings, producers should plan to schedule an appointment to visit their USDA Service Center at the earliest possible time. It's best to complete the paperwork now rather than to stand in line the day before the deadline," advised

The sign-up for both programs began Feb. 19, 2013. The deadline to sign up for ACRE is June 3, 2013. The DCP sign up period ends Aug. 2, 2013.

The 2013 DCP and ACRE program provisions are unchanged from 2012, except that all eligible participants in 2013 may choose to enroll in either DCP or ACRE for the 2013 crop year. This means that eligible producers who were enrolled in ACRE in 2012 may elect to enroll in DCP in 2013 or may re-enroll in ACRE in 2013 (and vice versa).
