Winners of the 5K Race were John Evans of Tuscola with a time of 17:47.10 and Austin Shelby of Charleston with a time of 17:47.11.

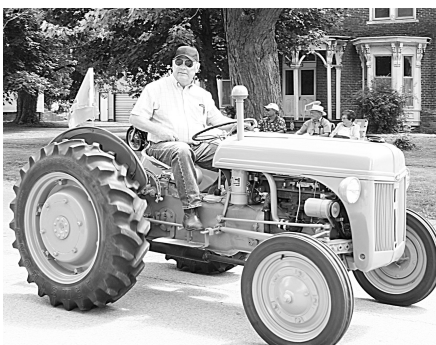
They all seemed to enjoy the music and time provided for them.

## Roadside Safety Checks in Douglas County

Pesotum, IL.— Illinois State Police, District 10, will be conducting Roadside Safety Checks in Douglas County during the month of June, according to District 10 Commander, Captain David Beasley.

Officers working this detail will be watchful for drivers who are operating unsafe vehicles, driving with a suspended or revoked driver's license, transporting open alcoholic beverages, or driving under the influence. Alcohol and drug impairment remain a significant factor in over 40 percent of all fatal motor vehicle crashes in Illinois. Safety checks are designed to keep our roads safe by taking dangerous DUI offenders off the road.

## Galey Throwing Hat in Ring For Sheriff

Douglas County native Fred Galey, age 57, is throwing his hat in the ring for the office of Douglas County Sheriff. He will be a Republican candidate in the March 2014 primary.

"I have continued to be encouraged by the citizens of Douglas County to run for sheriff again after losing to current Sheriff Charlie McGrew by only 39 votes in the last election. I will be running as a Republican candidate in the upcoming 2014 primary election. I would like to thank the voters of Douglas County who supported me and I hope I can count on you again."

Galey started his law enforcement career in the late 1970's, working both as a Tuscola Police Department as a patrolman and a patrol deputy for the Douglas County Sheriff's Office. He also attended the Illinois State Police Academy in 1980.

"During my 3 1/2 years working as a police officer in Douglas County, I worked all shifts and the duties including answering calls for service, traffic accidents, serving civil papers, investigating criminal offenses and was responsible for conducting residential farm security checks under Sheriff Gene Wigall's established program."

Galey left TPD and DCSO in 1981, when he was hired by the Las Vegas Metropolitan Police Department. After graduating from the department's 3 1/2-month police academy on Dec. 31, 1981, Galey spent another 3 1/2 months in a field training program, and then was assigned to the old downtown Vegas area.

He worked for the LVMPD for almost 27 years, on all shifts. Assignments included the burglary attack team, vice squad, McCarran Airport enforcing local and federal aviation laws, field training officer, larceny detail, and general assignment detective—a first-responder detective for

crimes ranging from larcenies to homicides.

Galey was also on the robbery detail, which included kidnappings, bank robberies, coin truck robberies, bar robberies, and home invasions. He served in a personnel capacity, as liaison officer for the department's health insurance; worked the sex offender detail, with a case load of about 120 offenders; the special victims section which included child and elder abuse—any type of injury including deaths and elder financial exploitation. His final assignment was the sexual assault detail.

Galey also was appointed by the Governor of Nevada to serve on the Public Employees Retired System as a board member for the Advisory Committee. He also served as secretary and treasurer for the Police Protective Association, the bargaining unit for the line officers; and he was a vice president for the International Union of Police Associations representing officers in Utah and Nevada.

"Among my plans for the sheriff's department is to keep the spending within the budget and at the same time provide all the training and the tools necessary for the men and women of the sheriff's department to complete their jobs in a professional manner. I believe there is always room for additional training of the employees.

"Because of my experience in criminal investigations, I plan to be involved in all criminal investigations, regardless of the severity of the offense. I have my own thoughts on how the department might better utilize the deputies to cover more patrol miles more evenly throughout the entire 24-hour day. I will have an open-door policy," says Galey.

Galey lives in Tuscola with his wife, Jeanette. They have two adult children and three grandchildren.

### Food, Fellowship, and Faith

I had a seminary professor mention in class that eating in the Bible implied fellowship. I think that is true even outside the Bible. You have visitors come to town, family or long distance friends, and eating seems to more often to be a part of the get-together. Here in Newman, it is not uncommon for people to drive all the way to Champaign or even further over to Indiana to the Beef House - all for the purpose of eating!

We witnessed the importance of food and fellowship this last weekend at the park for the Newman Freedom Festival. (By the way, a great job to Roger Sy, Brenda Moses, and all the others who gave of their time and hard work!) In any case, people look forward to the festival to see people near and far that come, but also for the food. There's just something about festival food—even though there is the danger of it running out!

Where does the Christian faith enter in? The world and unbelievers can have food and fellowship and surely they have faith, but not Christian faith. When it comes to food, the Christian recognizes it as a gift from God. This is why many will give thanks before partaking. The Bible even talks about fasting—usually understood as the foregoing of food for a period of time that is then devoted to God. When one hungers for food, it is almost like an earthly example of how our hearts should yearn for God. In this case, the absence of food brings heavenly fellowship.

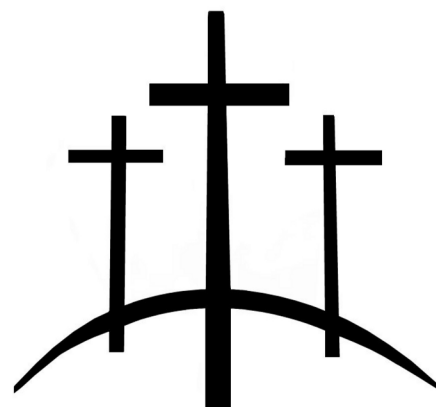
The Christian life was never meant to live alone. Yes, the acceptance and following of Jesus Christ is a personal choice that you must make and no one

can make it for you. However, the Christian life is meant to be lived out in community. Read the book of Acts and you will see that. Many believe that the early church had a fellowship meal along with the Lord's Supper. (What is it about church potluck meals—especially the dessert table!)

Even God by nature shows fellowship. Many wonder what God was doing before He created. Actually, we worship one God in Three Persons: the Father, the Son, and the Holy Spirit. Each Divine Person is fully God and thus is eternal since God by nature is eternal. What was God doing before creation? There was fellowship between the Three Persons of the Godhead.

This is not to be thought of in a sexual sense but the idea of intimacy is present as the redeemed that make up the bride of Christ are joined with Jesus. ## Pet Talk with Dr. Sally Foote DVM



### Myth Busting Heat Stress in Pets

I had a call come into the office from a rightfully concerned business owner, witnessing 2 dogs closed up in a car. Most of the people I meet understand that leaving a dog in a car AT ALL will be fatal. For those that don’t, many people remove the dog or call the police who do have the authority to impound and press charges. Having water in a car, or yard is not good enough. Here are some facts to bust the myths and misconceptions about heat stress in pets. Come to the heat stress talk at Jarman Center Saturday June 22 at 9 am to learn more.

**Myth** - If they have plenty of fresh water in a big bowl that will keep them cool.

Reality - drinking water replenishes thirst but does not cool them off. Dogs and cats cool off by laying on a cool surface to conduct heat away from the body. So they need constant cool earth that is in constant shade not a dog house in the hot sun.

**Myth** - An outside dog is better off outside than to adjust to the indoors.

Reality - If the indoors is giving the dog or cat what they need - cooling - the confinement will calm them not agitate them. So basements, garages with a concrete floor will be less stressful than the work they have to do to find cooling in hot weather

**Myth** - the little dogs and dogs with long hair have the hardest time in the heat.

Reality - the more dense the body - muscular large breed dogs such as boxers, bulldogs, pit bulls, Labradors, etc have the hardest time. Older dogs, especially if they have collapsing trachea or hear t problems also have a hard time and need have limited time outside in the day.

**Myth** - Riding in the back of a pickup truck is fine when it is hot - there are enough breezes to keep them cool.

Reality - Air does not flow into the bed of the truck, and the amount of heat reflected back up on the body can double the heat load on a dog. Sadly, we had a fatality that was due to riding in the back of a pickup. Sit in the back of a pickup on a hot day with a coat on and see how warm it gets.

**Myth** - panting cools dogs down fine. As long as they can pant they should be fine.

Reality - panting does cool a dog down to a point then it heats them up. It takes work to pant and that generates heat. It also dehydrates the dog. A dog cannot pant and drink enough to keep up

with the heat so soon they are panting excessively and overheat. Myth: shaving a long haired dog or cat will make them heat up more.

Reality - the long hair insulates against the heat only for a short while. Both dogs and cats need to get in contact with cool surfaces to cool off. The long hair prevents the conduction to the cool floor so get long haired pets a hair cut - most certainly the underside and sides of the body. No matter how silly they look, the hair will grow back by fall.

**Myth** - the shade of a building will be a good place to keep an outside dog cool.

Reality - the shadow of a building is cooler, but there is still the reflection of heat off the building coming onto the dog that limits the cooling. I have had cases where a dog overheated in the shade of a metal out building due to this heat reflection. Allowing this dog inside an insulated building is far better than the struggle to find shade and cooling earth outside.

These are some of the most common myths that my staff and I have encountered over the years of hot summers. Share this with your friends and neighbors. Come to the talk sponsored by Hands 4 paws 9 am at Jarman Center 704 N Main Tuscola Saturday June 22. There are still too many pets hurting in the heat.

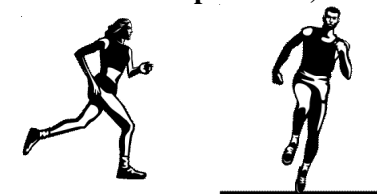

An 1847 meal, two historic sites, and the intriguing tale of Abraham Lincoln’s only time representing a slave owner make this an evening out of the ordinary. Lincoln’s Trial & Tribulations presents the 1847 Matson Slave Trial in a new intimate, dinner theater format in beautifulOakland, Illinois on June 29, July 13 and September 20. Tickets are now on sale and must be purchased one week in advance.

“We are excited about the new format which will be more personal than the previous years since only fifty tickets will be sold for each date,” notes coordinator, Renee Henry. This is the fifth year for the program that tells the story of the Bryant family seeking freedom from Kentuckian, Robert Matson, and how Lincoln became entwined “not on the side of the angels.”

The evening begins at 5:00 p.m. with tours of the Hiram Rutherford 1847 home and the adjacent Pennsylvania Railroad Depot which are operated by Oakland Landmarks, Inc. Lincoln’s participation on the side of the enslaver has fascinated historians, earning the trial a place in his top ten most important litigations.

The cast is a combination of dedicated local interpreters and professional actor/interpreters. The two Oakland abolitionists are played by Roger Ashmore of Oakland (Gideon Ashmore) and Kim McGee of Newman (Hiram

Rutherford). Robert Matson is portrayed by Ben Williamson of Newman. Marylee McGee, also of Newman, brings Matson’s future wife, Mary Ann Corbin to life.

Jane and Anthony Bryants are acted by Michelle Mimms-Duchan and LeVelle Harris who are regular members of Freetown Village in Indianapolis. Freetown Village is a living experience on black history that consistently presents



culturally sensitive programs in a manner that is unequalled. Their programs, like Lincoln’s Trial & Tribulations, help to build cultural bridges of mutual trust, inspiration, and knowledge.

Joe Woodard of Hazel Dell appears as Abraham Lincoln for his second year with the Oakland program, though he has been recreating the man since 1990. “I represent ‘A. Lincoln of Springfield, Illinois,’” Woodard said, “Lincoln,

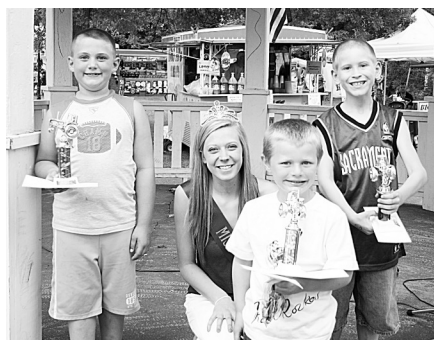

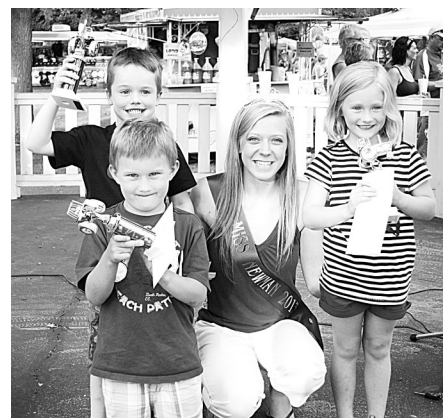

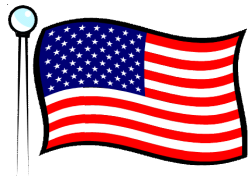

## Flag Day

During the American Revolution, the Continental Congress adopts a resolution stating that “the flag of the United States be thirteen alternate stripes red and white” and that “the Union be thirteen stars, white in a blue field, representing a new Constellation.” The national flag, which became known as the “Stars and Stripes,” was based on the “Grand Union” flag, a banner carried by the Continental Army in 1776 that also consisted of 13 red and white stripes. According to legend, Philadelphia seamstress Betsy Ross designed the new canton for the Stars and Stripes, which consisted of a circle of 13 stars and a blue background, at the request of General George Washington. Historians have been unable to conclusively prove or disprove this legend.

With the entrance of new states into the United States after independence, new stripes and stars were added to represent new additions to the Union. In 1818, however, Congress enacted a law stipulating that the 13 original stripes be restored and that only stars be added to represent new states.

On June 14, 1877, the first Flag Day observance was held on the 100th anniversary of the adoption of the Stars and Stripes. As instructed by Congress, the U.S. flag was flown from all public buildings across the country. In the years after the first Flag Day, several states continued to observe the anniversary, and in 1949 Congress officially designated June 14 as Flag Day, a national day of observance.

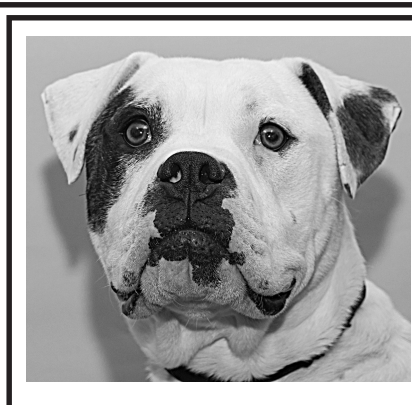
