## Shiloh School Board Discusses Building Options

After a weather postponement, the regular monthly meeting was held on February 19, 2014.

President Hales called the meeting to order at 7:00 PM in the Shiloh Board of Education room with Board Members Jason Dye, Dana Hales, Renee Henry, Stacy Luth, Aaron Richardson, David Smith present. Nelson Starkey was absent. Others Present: Superintendent/Principal Dr. John Wheatley, Principal Beth Harbaugh, Dr. Allen Hall, Jeri Luth, Terence Sullivan, Amy Kincaid, Missy Tingley, Janice Alexander, Scot Gregory, Chris Landstrom, Barb Board

Consent Agenda items: Special Meeting minutes of January 13, 2014; Regular Meeting minutes of January 20, 2014; January 2014 Activity Fund Report and January 2014 Treasurer's Report were approved.

Administrative Team Reports were given byMrs. Harbaugh, Principal PK-8 that included ISAT testing is scheduled for March 10 – 21; Distributed and reviewed a repair/replacement estimate from Royalty Roofing for the Newman Grade School roof. Estimate was a lot less than anticipated; A juvenile sink was ordered for the boys' elementary restroom; Paris Humane Society recently made a presentation to the third grade class. The class project was to collect chew toys for large dogs held in the shelter; 100 Day Celebration was held last Friday at Newman Grade School. Students participated in activities focusing on the 100<sup>th</sup> day of school; The Junior High boys basketball season ended with 8 wins and 8 losses for 7<sup>th</sup> grade and 11 wins and 6 losses for 8<sup>th</sup> grade. Congratulations to the boys and to Coach White for a respectful season; A tornado drill will be held the first week in March in both buildings.

Dr. Wheatley, Superintendent/Principal 9-12 thanked the Board and staff for the memorial donation honoring his mother; Distributed information regarding the availability of a vehicle for snow removal for sale. It has an electric dump so could be used for other things as well; Attended an LOVC meeting with Athletic Director Missy Tingley, earlier today. The vote for the co-op of sports passed unanimously. Shiloh will host track and softball and Tri County will host baseball. Because of the number of game cancellations this season due to weather conditions, Shiloh and Arcola high school girls basketball teams were declared Co-Champs this year; distributed information about the next Illini Division meeting; Encouraged board members to complete their School Board Training soon if they have not already done so; and apprised the board of this week's student activities included Winterfest and FFA Week.

Board approved the February 2014 expenses

A presentation by Chris Landstrom of Twin City Energy Services addressed the district's electricity needs and his proposal to save on electric rates by locking in the best rate early. Current contract with First Energy renews in October. ProLiance natural gas contract renews in November.

A second presentation by Janice Alexander and Scot Gregory of Aramark spoke to the Board's concerns regarding the food service program: meal count, leftover food, district's food service manager, and menus.

A third presentation by Jeri Luth of the Newman Regional Library presented a proposal for the library to lease 3,000 square feet of Newman Grade School. They request a separate entrance, 3-year lease, and occupancy in August 2014, at \$4,000 per year.

Discussion followed about the need to make a decision soon on use of the Newman Grade School building occurred: Board directed the administration to come up with specific use scenarios of the building for the next meeting.

The Board also directed the superintendent to contact the architect to schedule the Life Safety 10-year resurvey early as decisions cannot be made until they know what must be done to keep the building in operation.

Board Committee Reports – The Finance Committee met February 7 and discussed audit, food service, Debt Recovery Program, Affordable Care Act, Bushue Services, Newman roof repair, and the budget. They will meet again March 7 with Bushue Human Resources to discuss insurance issues.

Amy Kincaid, Shiloh Education Association President, voiced concern that they do not have enough substitute teachers because the District is paying the same rate as they did 15 years ago when she was a sub. She requested the Board consider raising the substitute pay rate.



Surely you desire truth in the inner parts; you teach me wisdom in the inmost place. Cleanse me with hyssop and I will be clean; wash me, and I will be whiter than snow.

Create in me a pure heart, O God, and renew a steadfast spirit within me.

Psalm 51:6, 7, 10

Sometimes when you don't quit while you're ahead, you just dig yourself in deeper. Charles Robertson, 19 years old, just didn't know when to stop. But then again, he shouldn't have started. He needed money and went to Jefferson State Bank to fill out a loan application. While there, he changed his mind, left, came back in a couple hours with a gun, a bag, and a note demanding money. The teller gave it to him and suddenly Robertson is holding a sack of money.

Realizing the police were probably on their way, he ran out the door and was halfway to his car when he realized he left the note at the bank. Thinking that could be evidence against him, he ran back and snatched the note from the teller. This time, when he reached the car, he couldn't find his keys. They were on the bank counter, left there when he retrieved the note.

By now, total panic set in. He went into a restroom at a fast food restaurant and climbed up into the ceiling where he hid the money and his gun. Running through alleys and assorted passageways, he finally reached his apartment. His roommate was oblivious to all of this and said, "I need my car."

How do you explain all of that to your roommate? Robertson lied and said the car was stolen. So the roommate called the police to report his stolen car. It didn't take long for the police to put the pieces together. They took the keys found at the bank, to the abandoned car a few blocks away, and then they went to the address of the one who reported the stolen car, and found Robertson. He confessed and was charged with robbery and put in jail. No bail. No loan. No nothing. No kidding.

Some days it's hard to do anything right. Every day it is even harder to do something wrong right. But we try. We might not have taken any money, but we have taken advantage of, or taken control. We said things, thought things, seen things, done things. We've given into fear and worry and discouragement and foolishness and the mood of the moment, which has resulted in all sorts of things for which we are not proud. So we hide not in alleys and passageways, but behind excuses. We really don't want anyone to know the truth, especially God. So we hide, we run from God. But from the beginning, God asks for honesty, not perfection, but truth.

That's what King David knew as he prayed his psalm, You desire truth in the inward being; therefore teach me wisdom in my secret heart. This coming Wednesday, March 5, is Ash Wednesday, marking the beginning of the season of Lent and our journey to the cross, and then on to Easter morning. This season is all about honesty, being willing to be honest with ourselves about who we are, and above all, about our relationship with God. It is a season of coming clean. We might not see the truth right away, so we ask God to guide us with His wisdom.

Getting honest, we call it confession, does for the soul what preparing the land does for the field. You know that before you first plant a field, you remove the stumps and large rocks. You spray it for weeds. Seeds grow better if the land is prepared. Confession invites God in to walk through our hearts and remove what blocks us from knowing His grace. God removes the stumps and boulders of our resentment and regret and foolishness, of our sin. As God walks through, his grace tells us that He still claims us. We still belong to Him. As we get so messed up with our foolishness, our poor choices, our thoughtless words, our sin, God comes to find us so that He can love us and take that sin from us.

I invite you to come and begin the journey this week. I know, Ash Wednesday can be an uncomfortable service, for who of us really wants to dig up all of the weeds and boulders of our hearts? We tend to live with them and work around them. Getting behind our excuses and being honest about who we really are often makes us squirm. Yet as we do, that is exactly the place where we begin to feel God's love and grace for us, for you, for me. You belong to Him.

## Health Points Douglas County Health Department submitted by Hanna Rogers, Environmental Health Inspector/Clerk Sipping, Snacking and Tooth Decay

Many parents across the country will issue a common refrain at dinnertime tonight: "You better eat that it's good for you! There's another old favorite in the parental arsenal of dietary admonitions: "Don't eat that—it'll rot your teeth! Now more than ever, kids are faced with a bewildering array of food choices from fresh produce to sugarladen processed convenience meals and snack foods. What children eat and when they eat it may affect not only their general health but also their oral health.

Americans are consuming foods and drinks high in sugar and starches more often and in larger portions than ever before. It's clear that junk foods and drinks gradually have replaced nutritious beverages and foods for many people. For example, the average teenage boy in the U.S. consumes 81 gallons of soft drinks each year! Alarmingly, a steady diet of sugary foods and drinks can ruin teeth, especially among those who snack throughout the day. Common activities may contribute to the tendency toward tooth decay. These include grazing habitually on foods with minimal nutritional value, and frequently sipping on sugary drinks. When sugar is consumed over and over again in large, often hidden amounts, the harmful effect on teeth can be dramatic. Sugar on teeth provides food for bacteria, which produce

acid. The acid in turn can eat away the enamel on teeth.

Almost all foods have some type of sugar that cannot and should not be eliminated from our diets. Many of these foods contain important nutrients and add enjoyment to eating. But there is a risk for tooth decay from a diet high in sugars and starches. Starches can be found in everything from bread to pretzels to salad dressing, so read labels and plan carefully for a balanced, nutritious diet for you and your kids. Reduce your children's risk of tooth decay:

- Sugary foods and drinks should be consumed with meals. Saliva production increases

during meals and helps neutralize acid production and rinse food particles from the mouth.

- Limit between-meal snacks. If kids crave a snack, offer them nutritious foods.
- If your kids chew gum, make it sugarless-Chewing sugarless gum after eating can increase

saliva flow and help wash out food and decay-producing acid.

- Monitor beverage consumption Instead of soft drinks all day, children should also choose water and low-fat milk.
- Help your children develop good brushing and flossing habits.
- Schedule regular dental visits.



#### BATTLE TESTED Raiders Poised for Playoffs with Strong Final Week of Regular Season

The key to having a successful season is how a team plays towards the end of the regular season and gets ready for the playoff push. For the Shiloh Raiders boys' basketball team, that time was last week. The final week of the regular season saw the men of the Blue and Gold looks to build momentum going into the start of the IHSA Class 1A Tournament and show that they would be a threat to make a run towards Peoria and the Class 1A State Finals. The week saw the Raiders face off against three solid LOVC teams and the play was indicative of that with Shiloh going 2-1 and having at times to dig deep and come from behind in key moments.

Tuesday night saw the Blue and Gold face off against the Villa Grove/Heritage Hawks and the visitors from the north came to play with quick ball movement and keeping stride for stride taking a 28-23 lead going into the locker room. The

A huge difference in the contest was the free throw shooting as the Raiders went 14 of 18 from the line for 78 percent while the Hawks only went to the line 9 times and made 6 of those attempts for 67 percent. Andrew Donithan finished with 20 points

leading four players in double figures for the Raiders as Cyrus Furgeson chipped in 15 and both Eli Furgeson and Kaleb Hood added 14 and 11 points respectively. Chance Lemmon had 14 points to lead the Hawks while both Lucas Vandeventer and Jordan Wolf added 13 points each in the loss.

The next night saw the Raiders head to Arthur to challenge the Arthur-Lovington Knights with sole possession of second place in the LOVC on the line. The teams faced off in the semi-finals of the LOVC Tournament with the Knights taking the first match-up soundly. This contest became an instant classic with the Raiders having a 7 point lead after three quarters, but the Knights tying it up in the fourth and send the game into an extra session. In the extra frame, the Raiders had two chances to take the win, but see their attempts fall just short as the Knights escaped with a 68-67

Tyler Schuring finished with 6 three point shots and a game-high 28 for the Knights in the win.

Peyton Hagerman led the T-Wolves with 19 points while Devon Still added 18 points and Joe Jeffers chipped in 11 points in the loss. The win secured the Raiders their

second straight 20 win season and gain important momentum going into the postseason this week.

The Raiders (20-7 overall, 5-2 LOVC) will have played their first round match-up on Monday in the Catlin Regional facing off against the Chrisman Cardinals. If the Raiders were to have advanced, they would have played on

Wednesday night against the top seed Milford Bearcats. The title game of this regional is set for this Friday night starting at 7:00 at Catlin High School in Catlin with a spot in the sectional round at Danville Area

Community College on the line. Basketball Central will follow the progress of the men of the Blue and Gold and have a full report for you next week as the Raiders look for their first regional title in 17 years.





#### **Douglas County Final Multiplier Announced**

SPRINGFIELD, IL, - Douglas County has been issued a final property assessment equalization factor of 1.0000, according to Brian Hamer, Director of the Illinois Department of Revenue.

The property assessment equalization factor, often called the "multiplier", is the method used to achieve uniform property assessments among counties, as required by law. This equalization is particularly important because some of the state's 6,600 local taxing districts overlap into two or more counties (e.g. school districts, junior college districts, fire protection districts). If there were no equalization among counties, substantial inequities among taxpayers with comparable properties would result.

Under a law passed in 1975, property in Illinois should be assessed at one-third (1/3) of its market value. Farm property is assessed differently, with farm homesites and dwellings subject to regular assessing and equalization procedures, but with farmland assessed at one-third of its agriculture economic value. Farmland is not subject to the state equalization factor.

Assessments in Douglas County are at 33.80 percent of market value, based on sales of properties in 2010, 2011, and 2012.

The equalization factor currently being assigned is for 2013 taxes, payable in 2014. Last year's equalization factor for the county was 0.9709.

The final assessment equalization factor was issued after a public hearing on the tentative factor. The tentative factor issued in December 2013 was 1.0000.

The equalization factor is determined annually for each county by comparing the price of individual properties sold over the past three years to the assessed value placed on those properties by the county supervisor of assessments/ county assessor.

If this three-year average level of assessment is one-third of the market value, the equalization factor will be one (1). If the average level of assessment is greater than one-third of market value, the equalization factor will be less than one (1). And if the average level of assessment is less than one-third of market value, the equalization factor will be greater than one

A change in the equalization factor does not mean total property tax bills will increase or decrease. Tax bills are determined by local taxing bodies when they request money each year to provide services to local citizens. If the amount requested by local taxing districts is not greater than the amount received in the previous year, then total property taxes will not increase even if assessments increase.

The assessed value of an individual property determines what portion of the tax burden a specific taxpayer will assume. That individual's portion of tax responsibility is not changed by the multiplier.

#### This week in History

During the bloody Battle for Iwo Jima, U.S. Marines from the 3rd Platoon, E Company, 2nd Battalion, 28th Regiment of the 5th Division take the crest of Mount Suribachi, the island's highest peak and most strategic position, and raise the U.S. flag, February 23, 1945.

Marine photographer Louis Lowery was with them and recorded the event. American soldiers fighting for control of Suribachi's slopes cheered the raising of

the flag, and several hours later more larger flag. Joe Rosenthal, a photographer with the Associated Press, met them along the way and

Marines headed up to the crest with a recorded the raising of the second flag along with a Marine still photographer and a motion-picture cameraman.

Rosenthal took three photographs atop Suribachi. The first, which showed five Marines and one Navy corpsman struggling to hoist the heavy flag pole, became the most reproduced photograph in history and won him a Pulitzer Prize. The accompanying

motion-picture footage attests to the fact that the picture was not posed. Of the other two photos, the second was similar to the first but less affecting, and the third was a group picture of 18 soldiers smiling

and waving for the camera. Many of these men, including three of the six soldiers seen raising the flag in the famous Rosenthal photo, were killed before the conclusion of the Battle for Iwo Jima in late March. From History.com


