

Steve Allen Receives Lifetime AchievementAward from the EIU College of Education and Professional Studies

Steve Allen graduated from Eastern Illinois University with a bachelor's degree in Speech Education in 1968. Following graduation, he enlisted in the Marine Corps and his service included a year as an infantry platoon commander

in Vietnam.

Psychology and Guidance in 1974. He served a year's internship in a model, followed by 27 years as Guidance Director for the Newman and Shiloh school districts.

During his tenure with the Newman/ Shiloh schools, Steve continued to work with his professors from EIU and with Dr. Richard James to create a developmental guidance program for rural schools. After that program model was published in the national *School Counselor* journal, he and Dr. James were invited to present the program's essentials at two national conventions. Upon retiring from the Newman/Shiloh schools, he worked part time as a counselor in the Kansas Treatment and Learning Center for the Eastern Illinois Area Special Education district for four

years. Steve was a 20year member of the Advisory Board of the EIU Department of Counseling and Student Development and supervised dozens of interns and practicum students for the department during his

As well as serving as an adjunct faculty member for the department for several years. Steve

received the Illinois Award for his work with the Illinois Association of Student Councils. He has served on Eastern Illinois Education for Employment System's Advisory Board for several years.

He is very active in his church and in service organizations. He and his wife Dianna raised their family on a small farm near Newman and still reside there, where Steve does truck farming and raises hay. The Allens have four married children and ten grandchildren - and the extended Allen family has received 14 degrees from EIU.

Charleston Riot of 1864 Has Family Ties to Newman

Young Ewing Winkler and son Robert Winkler of rural Newman were involved in the riot probably more than they anticipated. Young Winker helped his mother and eight siblings move to the area around Brushy Fork in 1829. He built the first permanent home in what is now Newman Township. Some of his brothers also moved to the area and build homes shortly afterward. The Harvey and Rae Winkler property now owned by John and Marge Albin was the original homestead of the Winker family. Harvey was a descendent of one of Young Winkler's brothers.

Young Winkler and his son Robert were both sympathetic to the southern feelings held by many families that had migrated from Kentucky and Tennessee to the east-central Illinois area. They along with others from the Bushton and Rardin, Illinois had ventured to the Coles County Court House in late March of 1864. They met up with other groups of anti-Lincoln prosouthern men from Edgar County.

Court was in session with Judge Charles

Constable presiding. There were suppose to be some political speeches by pro-Lincoln presenters during the day. Union soldiers home on leave were present during the day also and a conflict erupted between the soldiers and the southern sympathizers (the Copperheads).

In that ensuing riot on the court house lawn, six soldiers were killed and 3 civilians were also killed. 12 other persons were wounded.

Young Winkler and his son Robert were two of the wounded at the riot. They both suffered serious wounds but were not of the life-threatening type.

After the conflict, most the Copperheads ran east on Jackson Street from the Cournt House and escaped. The Winklers fled back toward Bushton and Rardin andout of the area not returning back to Newman.

50 Copperheads that were involved were later captured and eventually held in prison on the east coast until President Lincoln had them released and returned to Illinois without any further charges.



Riot in Charleston Illinois Sunday Afternoon

a little more love and care. Just the same, the blessing of good weather has an effect on all aspects of our life. Problems might seem a little lighter and the future might hold a little more hope as the earth warms and the days grow longer.

However, the promise of better weather and more sunshine does not really help our spirits if we don't take in more of the SON shine. (Yes, I apologize for the pun, but it just came out). We need light in our hearts as well as on our bodies to truly appreciate our lives. So many people don't realize that unless they take Christ into their daily lives, they won't see the blessings they experience in their daily lives. My granddaughter is teaching

preschool in a mission school in Port de Paix Haiti. If you are making comparisons, this would be the poor area of a poor nation. I went with family to visit her in February and did a little work, toured the school where she teaches, and met truly devoted people. While there, I was amazed at the living conditions of the people. Poverty is real in Haiti-it doesn't mean that your car is old, it means that you don't have a car, or a road for that matter. People are accustomed to their life so they probably don't expect too much to come from it-they assume that they will be poor until death. However, they live each day trying not to die, for there is no hope in the afterlife for them. With no hope in this life and no hope in the afterlife, there is a miserable existence where improvement for the next generation is not at a premium.

This was such a contrast to the students at Sonlight Academy who were being instructed in English, French, math, science and the Bible. To these students, the future is promising. The mission of Sonlight Academy is to educate the Haitians to lead their own country out of the physical poverty they now suffer and out of the spiritual poverty of Voodoo. Having seen the children outside of Sonlight and the children inside of Sonlight, I realized that they have the same needs and could have the same dreams. They have the same soul that needs redemption. (I'm not getting preachy here-I need redemption every day and

I can hear a lot of you saying AMEN!) Even so, the truth is there is light in Haiti and every nation on earth. I am humbled and stand in awe of the dedication of the teachers and ministers in places where they face daily hardships and the separation from their families. I know that I couldn't do it. For those of you who have told me "Yes you could, you would be great at it" no I couldn't do it and after a couple of days the poor of the nation would gather enough money to pay my way back home.

There are blessings for people in Haiti who will see them and there are amazing

blessings for those who will receive Christ. Those same blessings are for us. Today try not to look at what you don't have. Look at what you do have. If you want more in your life, don't look at this world, look to God. He really wants to give you more than you have right now.



"Public Health: Start

Here" is the national theme for Public Health Week, April 7-13, 2014. The Douglas County Health Department is proud to be in a county that ranked 7th in the top 10 healthy counties of the State of Illinois's 102 counties this year. The Department invites you to start by learning about their services offered and making use of the ones that are appropriate for you. Services are available for everyone from infant to the centenarian.

- Infants and children younger than 5 years of age with their parent, guardian or caretaker may qualify for WIC which is a federal nutrition program that provides: nutrition education and counseling, breastfeeding support, nutritious foods, and referrals to other helpful services. You may have a job and still meet these guidelines (for example, a family of four can earn up to \$43,568.00 a year, gross amount).
- Immunizations by appointment monthly the 1st Thursday (1pm 4pm) and the 3rd Wednesday (3pm 4pm). Immunizations are not just for children; adults need boosters and as they reach 60, the shingles vaccine is available.
- The Nail Clinic is held the 3rd Friday of the month by appointment for those seniors who need assistance with trimming their toenails.
- Health services include lead screenings, pregnancy screening, onsite lab services, and HIV testing.
- Oral Health Services include preventative and restorative services as well as endodontic and prosthodontic services.
- Environmental services include food sanitation, water testing for private water supplies, private sewage system permit program, tanning and body art

Pet Talk with Dr. Sally Foote DVM Be Ready for Mosquitoes and Fleas

Spring is getting off to a slow start, so who would think about fleas, heartworm or ticks now? These short spurts of warm weather actually get these little bugs ready to hatch out with a vengeance. Be prepared and prevent health problems by choosing the right product for your dog or cat according to your pet's lifestyle.

Heartworm disease is spread by the bite of a mosquito. Mosquitoes can start hatching out and biting when the average day time temperature is 40 degrees Fahrenheit. What this means is that on these March days when the temperature rises to 45 or 50 degrees, the mosquitoes will swarm and bite. They go dormant for the night when the temperatures fall but will not die off unless there are a few days well below 32 degrees. Monthly heartworm preventatives are a safe and effective way to prevent this deadly disease.



Monitoring your dog for heartworm is

important to be sure they are getting

the proper dose of prevention every

month. There is also a resistant strain

testing for heartworm is not as reliable as in the dog, and prevention for them is also important. 

If you have to remove a tick, use alcohol and tweezers. Some of the extension offices can test the tick to see if any of the diseases are carried by them.

Fleas - yep, they are still around. Many people have fleas living in the home over the winter because they carried them in over the fall. For a lot of pet owners a year round flea program is best. A flea comb is a good investment to check your pet over regularly. You can find these at a pet store. Remember 1 flea can lay up to 100 eggs a day which a month later will hatch out. The house treatment sprays must contain a growth inhibitor (precor) to be effective. Most of the over the counter house treatment sprays do not carry this, but the Siphotrol is one available at most veterinarians that does contain the growth inhibitor. Treat all surfaces your pet comes into contact with, and repeat

Stay ahead of the bugs and have your dog tested and back on heartworm prevention if you stopped at all. Be sure you have your flea and tick products handy as well. 

Concealed Carry in Illinois by Dana Hales

Concealed Carry has now been approved in Illinois since last summer. The state of Illinois worked on the details and requirements for implementation through the summer and last fall with certified instructors for the training starting in the last quarter of 2013. Completion of the courses in October and applications processing began in January of this year with the first concealed carry licenses being issued the first of March 2014.

Although the information is available on the Internet and the application process is clearly stated, there are some misunderstandings and concerns about the program. I took the opportunity to speak with a certified instructor from our area, Scott Bowyer of rural Hume, IL and who has been issued a license, about the program and questions that have commonly arisen on the proper procedures to acquire a concealed carry license. The following is a question/ answer format about those concerns.

Q. Are fingerprints required?

A. Yes and no. The state has 90 days to determine if an applicant is licensable if fingerprints are submitted with the application. Without the fingerprints, the state has 120 days to determine if the applicant is licensable. The fingerprints taken electronically only, must be submitted by noting the Transaction Control Number of the fingerprinting, on the application within 30 days of the fingerprinting.

Q. Prohibited Places

at anytime.

A. An individual with a concealed weapon entering private businesses that have posted notices not allowing concealed firearms is in violation of a class B Misdemeanor with a fine of \$150 for the first offense and a 2nd time is a Class A Misdemeanor with a suspension of the license for 6 months and a 3rd violation is a loss of the license. The exception is nuclear facilities and federal buildings and property where you cannot have a concealed weapon on the property

Q. Will private property /businesses regulations be modified?

A. It will not become a legislative issue in current times, so your choice to not patronize certain businesses anymore is a choice individuals would make.

Q. What does concealed carry mean and does it allow for open carry?

A. There is no open carry of firearms allowed by citizens of Illinois. The law definition for concealed carry is defined by the law as concealed or mostly concealed on or about one person.

Q. Can I carry into a place that serves

A. If the establishment received 51% or more of its sales from food served, you can. If the reverse is true, you cannot.

Q. What do I say to a police officer when asked if I have a weapon on or about my

A. Yes, I am licensed to carry.

Q. How is the application process going with the Illinois State Police since January when you could finally apply?

A. Your computer must have Java capability and scanner availability to scan a current photo of yourself and your training certificate(s). You must be sure to only submit the Illinois State Police completion certificate form. You will be asked to submit your Illinois Drivers License number twice (once to access the application and a second time in the application process). Make sure you enter your name, address, etc. the same each time as it apprears on your Illinois Driver's License when asked. Make sure your physical description (weight) matches your driver's license. If you have moved in the last 10 years, have that address available to submit. When it asks for the instructor's name, type in the last name first and the computer will fill in the rest of it. Payment may be made by credit card or by e-check. In July, there will be a paper enrollment available as well as the computer.

Q. How many rounds of ammunition and at what distance will I shoot to a target to have a qualification score?

A. You will shoot 30 rounds at a 24" x 45" B series target, at 5 yd., 7 yd., and 10 yd. – 10 rounds each. You must score 21/30 shots inside the 7 ring during the firing.

Q. Is my Concealed Carry permit acceptable in other states?

A. Illinois permits are accepted in 17 other states. No other state requires as much

for reciprocity laws. Q. Can non-residents of Illinois apply

for a concealed carry permit? A. Yes, there is legislative intent for nonresidents but due to regulations, only Hawaii and North Carolina residents may apply. Illinois and Hawaii have mandatory reporting to the state police of involuntary committal and voluntary committal to mental health facilities/ hospitals.

On March 30, 1981, President Ronald Reagan is shot in the chest outside a Washington, D.C., hotel by a deranged drifter named John Hinckley Jr.

The president had just finished addressing a labor meeting at the Washington Hilton Hotel and was walking with his entourage to his limousine when Hinckley, standing among a group of reporters, fired six shots at the president, hitting Reagan and three of his attendants. After firing the shots, Hinckley was overpowered and pinned against a wall, and President Reagan, apparently unaware that he'd been shot, was shoved


