

Newman Regional Library Celebrates National Library Week by Renee Henry

Newman Regional Library offers free programs throughout the week of April 13-19 including an opportunity to return overdue items without getting fined.

Children 13 and under are invited to enter our photo contest based on the Summer Reading Program's theme, "Paws to Read." Children can submit a photo they have taken with either a camera or a phone through the library's website at

www.newmanregionallibrary.org

between April 13 and 18. Judging will be on April 19 and winners will be announced on Monday.

Junior and senior high students are invited to a Divergent Party on Friday, April 18 from 7:30-9:30 p.m. at the library. Whether or not you have read the book or seen the movies this event will tap all sides of your personality. Students may choose to dress as their favorite faction. Activities will represent each of the five factions and include something for everyone: art,

video games, good food, social and brain games. RSVPs are appreciated but not required. Call, text, or message the library to RSVP.

Fine forgiveness comes once a year at the library during National Library Week. Anything that is turned in late that belongs to Newman Regional Library will have no fine during the week of April 13-19. So if you forgot to return a book two years ago, now is the time to bring it back because it won't cost you a dime.

In addition, if a patron has late fees already, he or she may bring in a non-perishable food to be donated to the Murdock Food Pantry. For each item, the library will remove \$1 in fines. Only fines for items belonging to Newman Regional Library can be waived with the canned goods.

During this week that highlights libraries and their importance to the community, NRLD also holds the annual giving campaign to raise money to augment the tax-based income. The

goal is to raise money to enhance library services beyond the basics such as adding to the new video game collection, new movies; and offering a strong summer reading program.

Letters in bright yellow were mailed to each household in the library district requesting a donation which can be delivered to the library in person, mailed in the addressed envelope, or through Paypal from the library's website.

Earlier in the week, Megan Peters, owner of Just Vintage in Tuscola who lives just outside Newman, presented ideas on how to decorate your home with items from the 1930s-1970s. How Good an Ancestor Will You Be? By Marlene Lincoln

The Stephen A. Douglas Chapter, NSDAR, is always interested in genealogy and how to find ancestors. But a recent publication by an Idaho DAR member puts the emphasis on US to be good ancestors ourselves! We should be preparing this information for our great-grandchildren and beyond. This means that we, as individuals, must write down what we know about the generation before us, about our children, the in-laws, EVERYONE. 
Carol Castellon of Savoy, who serves as our chapter's District Director, presented her findings about how the 11 chapters in our district got their names. For example, the chapter centered in Watseka is called Princess Wach-E-Kee Chapter because of a legend based on the daughter of a Pottawatomie chief; she challenged the tribe's reluctant warriors to regain their village that was attacked and destroyed earlier in the day by a group of

Iroquois. Of course our own chapter - Stephen A. Douglas - is named for a popular and skillful orator and political leader at the time our county was founded. An interesting fact about Douglas is that after the 1860 election he volunteered his services to President Lincoln to tour the border states to promote the Union cause.

Members of the chapter brought items and stories of their ancestors to the April meeting at Villa Grove Monical's; a biscuit jar and an Irish Bible were among some items while the stories ranged from an Indian attack to a 1858 medical doctor who was distressed that he might miss the Lincoln-Douglas Debate in Jonesboro just because a baby (a member's ancestor) might be born at the same time.

Commemorative Events Chairman Charlotte Wax told the story of Ellis Island which was named after Samuel Ellis, a New York merchant who bought the island during the Revolutionary War and built a tavern to cater to the fishermen; state of New York bought it from his family in 1808. The U.S. government paid the state of New York at the time of the War of 1812 for the right to store ammunition there; when the Federal Government closed another immigration station in New York, they moved the operation to Ellis Island on April 18, 1890. By the time Ellis Island closed sixty years ago (November 1954) 12,000,000 immigrants had been processed through it. Today, over 40% of Americans can trace their ancestry through Ellis Island.





The Bodily Resurrection of Our Lord and Savior Jesus Christ

This Sunday, April 20th, we celebrate the bodily resurrection of Jesus Christ— the One the Old Testament prophets foretold and the founder of the worldwide movement of Christianity.

It is interesting the place the resurrection plays in the Christian faith. Some have tried to redefine it saying that the resurrection simply means that the life of Christ lives on in our hearts. He never literally rose from the dead, so they say; He is only "resurrected" in our hearts and His teachings live on.

However, the Bible is very clear that when we refer to the resurrection of Christ, we are stating that Jesus Christ literally and bodily rose from the dead. This was not a resuscitation or a reincarnation. Jesus Christ, who truly dead, also arose.

Now, the Bible actually records others who had died but later was brought back to life. We may hear stories from medics and others who testify that the person was dead but brought back to life. Does that cheapen the resurrection of Jesus? Not at all. Jesus' resurrection is different because one, everyone else who is brought back to life, still dies. Jesus never died after the resurrection. But secondly, Jesus was raised not only in the same body, but it was a glorified body. Those who are brought back to life today still have their natural bodies, sometimes even in worse shape, and

How do we know that Jesus is the literal risen Lord? That He arose bodily? Much study has gone into this and the reader is encouraged to consult Josh McDowell's classic The New Evidence that Demands a Verdict.

My favorite two proofs are the absence of the body and the importance of the first day of the week. Concerning the first point, after all these years, the body of Jesus still has not been found. We can travel to the tombs of other religious founders (Muhammad, Joseph Smith, Confucius, etc.) but there is still no body found for Jesus. Produce the body and you destroy Christianity.

Secondly, the change in the day of worship. Jews have always treasured the weekly Sabbath corresponding to our Friday sunset to Saturday sunset. The early Church was Jewish and yet, the Church, from the outset, started placing the emphasis on the first day of the week, making that day the day of worship. Why so? Only if something significant took place on that day of the week. To the Christian, we believe Jesus rose bodily from the grave.

If God the Father had never raised Jesus from the dead, we would never know if what Christ did on the cross was sufficient for mankind. Romans 10:9 says: "That if you confess with your mouth, 'Jesus is Lord,' and believe in your heart that God raised him from the dead, you will be saved" (NIV).

Health Points Douglas County Health Department

In 2013 West Nile Virus continued to be a problem in Illinois and in Douglas County. Last year in Douglas County alone, a bird and three horses tested positive for West Nile Virus. West Nile Virus (WNV) is transmitted by mosquitoes and is most prevalent during late summer months (late Julylate September).

In hot, dry weather, mosquitoes that carry West Nile disease breed in stagnant water, like street catch basins and ditches, discarded tire covers and multiply rapidly.

Listed below are a few tips to help reduce exposure to you, your family and your animals:

REDUCE your exposure to WNV by avoiding being outside during the most active mosquito times (dusk through dawn).

- Repair any tears to screens in your homes. Limit the entry points for mosquitoes
- Eliminate sources of standing water on your property such as pots, bird baths, flower wading pools, old tires, or children's play areas

REPEL! When outdoors, wear socks, shoes, long pants and a long-

sleeved shirt, and apply insect repellent that contains DEET, picaridin, oil of lemon eucalyptus or IR 3535, according to label instructions. Consult a physician before using repellents on infants. **REPORT** Beginning late April or early May, dead birds should be reported to the Douglas County Health Department; the date will be announced in the county newspapers and on the Douglas County Health Department website, douglascountyil.com/ healthdepartment when the date is finalized. The dead birds being tested will be crows, blue jays,

robins and other perching birds. When a bird is observed to have died recently, notify the health department to receive further instruction as to how to submit or have a bird collected. The Douglas County Health Department will deliver the bird to the state lab for testing. Please, contact the Douglas County Health Department at 217-253-



City Council Meets With a Full Agenda

Mayor Allen opened the meeting at 6:30PM on Monday, April 14th with all members present except Kevin Tracy. He came in at 7:40PM. Visitors included Roger Sy, Adam Milburn, Jim Crane (County Engineer) and Dana Hales.

The council approved the minutes of the March meeting, the treasurer's report, payment of bills and then allowed those present to address the council. Jim Biddle came to inform the council on the Fireworks program for the summer festival. He has raised \$3946.66 to date and asked the city if they were willing to donate anything to the funding. After discussion and realizing that no money was donated last year because sufficient funds had been raised, the council decided to approve \$1400 towards the fund now because the fireworks order must be turned in by the first of May to guarantee delivery by the festival date. Biddle indicated that any further money received would go towards funding the following year's festival program.

Roger Sy was there on behalf of the Festival. He indicated that Jim Young had already received approval for the closing of the Yates Street for the Saturday events and possibly using it also for the Kiddy Tractor Pull if the day for it was

changed to Saturday afternoon. He also questioned the council on renting more Porta-potties including handicapped accessible ones and sanitizing stations for the festival. The council indicated they would ask about those concerns when contracting for them

Adam Milburn, representing the Youth Baseball programs had procured estimates on the repairs and roof needs for the concession stand at Memorial Park. \$420 would buy all the needed supplies to replace the roof and any materials for its completion. The City employees would do the necessary work with the Baseball program assisting. The council approved the expenditure. A pile of brick dust used on the baseball field was donated to the Youth Baseball program to use at other sites providing that they would haul it

The James building was discussed because the brother of the owner of the property wishes to acquire it. After some discussion on the condition of it and what it would take to be acceptable by engineering standards, Mayor Allen

Confidence Continues to Build as Raiders Stay Even for Week

Confidence and trust is a vital part of how a team plays together. With this year's Shiloh/Tri-County Raiders softball team, it was a case of blending players with experience from Shiloh with players from Oakland that never have played high school softball. After last week's action, the confidence is getting bigger and bigger each time. The ladies of the Blue and Gold continued to show some flashy work on the defensive end along with some strong run production to go 1-1 during the week and getting ever closer to equaling last year's win total this early in the season showing the rest of the area that this is not your typical Raiders squad from the past.

The week was to have started off on Monday and Tuesday with home games against the Arthur-Lovington/Atwood-Hammond Lancers and Urbana Tigers respectively. As per usual here in Central Illinois, spring rains came across the area on Monday with steady rains that made conditions unplayable for both days despite bright sunshine on Tuesday to

force both games to be cancelled. The contest against Urbana has been rescheduled for April 22 while there is no word on the A-L/A-H games as of yet.

The team then headed into a huge LOVC contest on Wednesday against the Arcola Purple Riders in Hume with first place on the line. These two teams met in last year's Broadlands Regional championship game with the Purple Riders holding on to take the crown and the first installment of this year's rivalry would set the tone for the rest of the season. The defense came to play with a key sequence coming in the top of the fourth inning as Jade Emery quickly tossed an errant throw from right field to Jessica Hunt to gun down a Purple Rider runner at the plate to keep the game close at 3-0. Unfortunately for the offense, they ran into Taylor Edwards on the opposite side. 



appointed Tracy and Berry to contact the prospective buyer and discuss needed compliance repairs and completion times before possible purchase of the site.

Roof repairs for the city building were tabled until next month

Councilman Benner distributed copies of the proposed budget for the upcoming year and gave an overview of its content. After some discussion, Barry made a motion to accept the tentative budget which received and second and was passed on a 5-0 vote. It has a deficit of \$50,000 but the city has \$250,000 in savings available.

Jim Crane, County Engineer was present to discuss the Motor Fuel Tax monies and the resolution to adopt the MFT Budget for maintenance of streets and highways within the city. The resolution was for \$31,100. After some discussion, Gordon made a motion to approve the resolution with Barry seconding the motion. It passed on a 6-0 vote.

Dennis Kibler spoke briefly about the demolition of the Dime Store building and the final portion of the demolition of the bricks. A request to close an alley that runs west to east from Coffin Street to Hopkins Street north of the Funeral Home was discussed. After some discussion the request was tabled until May so more information about utilities and other concerns could be answered.

Cameras for security of the city building were brought up by Councilman Gordon. He had found multiple companies that supplied such items and also found out that the city would see a reduction in the insurance rates if they were acquired. Some discussion followed with the concern to be tabled to May to find out more about the savings on the insurance premiums and monitor placement locations within the building.

An amendment to the city ordinances concerning Concealed Carry of Firearms was brought up. The current city ordinance does not allow concealed carry within the city. It was requested to amend the ordinance to comply with state guidelines. Another amendment about Burning on properties was discussed but tabled until May.

The Vacation Bible School would like to have a lock-in program at Memorial Park on May 30 for 5th-8th Grade students. The council gave their approval for this


At 8:55PM Councilman Gordon made a motion to go into closed session to discuss litigation and I went home.

successors, Booth hoped to throw the U.S. government into disarray.

On the evening of April 14, conspirator Lewis Powell burst into Secretary of State Seward's home, seriously wounding him and three others, while George Atzerodt, assigned to Vice President Johnson, lost his nerve and fled. Meanwhile, just after 10 p.m., Booth entered Lincoln's private theater box and shot the president in the back of his head. Booth leapt to the stage braking his leg but managed to escape Washington on horseback.

About 7:22 a.m. the next morning, Lincoln, age 56, died. Booth was pursued by the army and finally cornered in a barn near Bowling Green, Virginia, dying from a bullet wound. Lincoln was buried on May 4, 1865, in Springfield, Illinois. Attributed to History.com
